Food Service Manager's Certification Training **1-DAY CLASS w/8 Hours of Self-Study**

Are your employees certified in food safety? If you sell or serve food in Baltimore City, Baltimore County, Howard, Montgomery and Prince George's Counties, you are required to have a certified food safety employee on duty at all times? Food safety employees must pass an approved certification course. ServSafe® certification is nationally accepted as the standard of food safety certification and ensures that you will meet the requirements of any jurisdiction in Maryland. Your certification is valid for 3 years.

ServSafe® certification is recognized by state and local jurisdictions and meets or exceeds requirements for local regulatory compliance.
